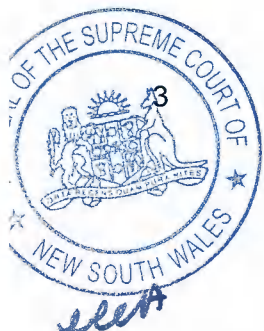
### ORDERS SOUGHT

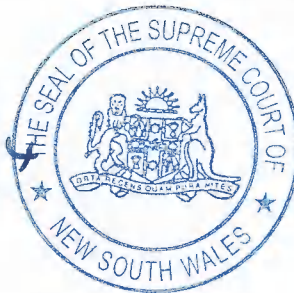
